

Announcement: Moody's: No impact on rating of BELVEDERE SPV S.R.L following the implementation of the ReoCo structure

Madrid, June 28, 2019 -- Moody's Investors Service ("Moody's") announced today that the implementation of a real estate operation carried out by a company expressly incorporated pursuant the Italian securitisation law whose purpose is mainly the acquisition, management, resale, upgrading and development of real estate assets (ReoCo), will not, in and of itself and at this time, cause the current Moody's rating of the debt issued by the Issuer to be reduced or withdrawn.

Following the amendments to the documentation, the ReoCo will be able to intervene in the real estate auction for a total maximum amount of EUR 90 million in terms of purchase price (i.e. debt assumption). The resale of the properties will need to occur within 3 years after the purchase, otherwise the ReoCo will grant an irrevocable mandate to a professional to sell the properties. Before full reimbursement of the Class A Notes, the financing of the ReoCo to purchase and to manage the real estate properties, as well as the ReoCo fees, will be provided by the ReoCo quota holders, i.e. Bayview Global Opportunities Fund S.C.S. SICAV-RAIF as management company of its three sub-funds. Any payments from the issuer to the ReoCo will occur after the full reimbursement of Class A and Class B only. Moody's determined that the ReoCo structure supports the alignment of interests between the Class A Noteholders and the activities performed by the ReoCo.

The last rating action for Belvedere SPV S.r.l. was the assignment of a definitive rating to the Class A Notes on 21 December 2018.
