One year of venture capital All 2019 announced funding rounds

The Italian venture capital market closed 2019 with numbers up sharply on 2018, considering all types of capital that Italy-based startups or startups founded by Italians raised from every kind of investors, whether they are structured as venture capital funds or investment holding companies, but also corporates, business angels and the crowd of crowdfunding equity platforms. What is particularly striking is the growth rate of the number of deals and especially the increase in the number of scaleups, i.e. startups that are growing and attracting increasing investment volumes. The data comes from **BeBeez Private Data** (the **BeBeez** database available on subscription, click here for information and for an **upgrade of your BeBeez News Premium subscription**), which has mapped announcements of closed venture rounds of **244 startups and scaleups** for a total of approximately **605.6 million euros, up sharply from 510 millions,** spread across 179 companies in 2018. include not only pure equity raised by companies, but also venture debt. If we do not consider venture debt, the figure for 2019 is reduced to **550.6 million euros** (net of 55 million of debt raised by **Casavo** and disbursed by an international fund, see here the article by *Beez*) and figure for 2018 is down to **480 millions** (net of 30 million euros of debt raised by **MotorK** from the **EIB**, see here the article by *BeBeez*), indicated in the **BeBeez 2018 Venture Capital Report.**

The figure also includes capital raised in **equity crowdfunding campaigns**. According to data from **CrowdfundingBuzz**, (the information platform owned by **EdiBeez srl** as well as *BeBeez*) equity crowdfunding as a whole in Italy has raised 65.6 million euros in 2019, of which about 16.5 millions went to finance real estate initiatives (see here **the article by** *BeBeez*).

For the purposes of the report on venture capital activity, however, *BeBeez* did not consider the figure for the fundraising of real estate projects here and also left out of the calculation the 2.83 million euros of capital raised by vintage soccer team **Pordenone Calcio** on **TheBestEquity** (see here the

article by *BeBeez*), since it is certainly not a company in its early stage of life. Likewise, for the purpose of this report *BeBeez* does not consider the rounds opened at the end of 2019 by startups that are still raising capital on equity crowdfunding platforms, some of which are bringing home quite important numbers for the Italian scene (for example, the fintech startup **Soisy** opened its campaign last November, see here the article by *BeBeez*, and to date has reached over 2.2 millions). The

remaining 25.6 million in equity crowdfunding, on the other hand, concerned 102 companies and are part of the total 565 million euros.

In reality, however, the bulk of the equity crowdfunding fundraising is concentrated in the hands of 12 companies that alone have raised as much as 26 million euros. At the top of that ranking are **SixthContinent** (3 millions) and **Italia Startup** (2.66 millions), followed by **Innovative RFK** (2.5 millions).

Returning to the overall figure, 2018's figure was biased by the 100 million euros mega-round, raised by **Prima Assicurazioni** and funded by **Blackstone** and **Goldman Sachs**. We have not had rounds of this size in 2019, but several large ones have been seen anyway, starting from the 62 million dollars one of the social fashion app **Depop**, the 61 million dollars one of the fintech **Soldo**, the 44 million euros one of the leader of the co-working **Talent Garden**, the 35 million dollars one of the fintech scaleup **TrueLayer** and the 20 million euros one of the **brumbrum** car e-commerce platform.

At the top of the list of those who have raised the most during 2019 is **Casavo**. In fact, this proptech scaleup cashed in 82 million euros in three rounds, of which 27 million euros in equity and, as already mentioned, 55 million euros in debt. In total, the top 7 companies in the ranking,

selected among those who announced rounds of at least 20 million euros, took home this year a total of 328.34 million euros. It should also be noted that there are 24 other companies that have raised rounds of at least 3 millions, for a total of over 162 millions.

So, in total we are talking about 31 companies that have raised 491 million euros this year in rounds worth 3 millions at least. A figure that beats 2018's numbers. Throughout 2018 there were actually 31 super-startups and scaleups based in Italy or founded by Italians who had announced rounds worth 3 million euros at least for a total of over 408 millions, but we have already seen that this figure included the 100 million euros "extraordinary" round of Prima Assicurazioni. Without that round,

we can say 2019 has far surpassed 2018. As for 2017, only 13 startups had raised rounds worth 3 millions or more for a total of 110 million euros.

The other important figure is the one relating to the **total raising of capital** that these same startups and scaleups who announced rounds in 2019 have raised since the beginning of their activity. We are talking about **more 850 million euros**, which is certainly a significant figure, but it also shows how much the investment activity of the last year alone weighs on this figure. Evidently the attractiveness of our startups and scaleups is growing.

Finally, there was a certain m&a activity on Italy's venture-backed startups. In particular, it is worth mentioning that **H-Farm** divested completely from **Depop** in January 2019, after a first partial exit in January 2018. The transaction as a whole generated a return of 6x the initial investment for H-Farm, with total proceeds of 4.57 million euros and a capital gain of 3.78 millions (see *BeBeez* article).

Then there was the acquisition of the entire capital of the fintech startup **Neutrino**, the Italian platform for the analysis, investigation and identification of illegal blockchain transactions, by the US platform for buying and selling bitcoin **CoinBase**. Neutrino received a funding round in 2017 by **360 Capital Partners**, which thus held a 30% stake (see *BeBeez* article).

Last July it was listed on Aim Italia **CleanBnB**, the leading Italian platform for short-term rental management, which raised 3.9 million euros, or 26.42% of post-money capital, in the ipo. CleanBnB had previously received funding from **Boost Heroes**, the business angels of the **BacktoWork24** network and the investors who participated in two equity crowdfunding campaigns made on the **CrowdFundMe** platform (see *BeBeez* article). Still speaking about IPOs, also **i-RFK**, after an equity crowdfunding campaign again on CrowdFundMe, on 27 December landed on Euronext, in this case without raising additional capital but making liquid the investment conducted shortly before by the crowd of the platform (see *BeBeez* article). On the other hand, there were no IPOs made by companies that had traditional venture capital funds among their shareholders.
